

The MOSFETs in this device are sensitive to electrostatic discharge. When handling this device, the worktables, operators, soldering irons and other objects should be protected against anti-static discharge.

Note: The channel-to-ambient thermal resistance, R<sub>th(ch-a)</sub>, and the drain power dissipation, P<sub>D</sub>, vary according to the board material, board area, board thickness and pad area. When using this device, be sure to take heat dissipation fully into account.

Note 1: Let V<sub>th</sub> be the voltage applied between gate and source that causes the source current (I<sub>S</sub>) to below (0.25 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ . Take this into consideration when using the device.




Fig. 6.3.1 Switching Time Test Circuit





Fig. 7.1 Marking




Fig. 9.1 Is - Vss




Fig. 9.3  $I_S$  -  $V_{GS}$ 




Fig. 9.5 IF - V<sub>F(S-S)</sub>




Fig. 9.2 R<sub>SS(ON)</sub> - I<sub>S</sub>




Fig. 9.4 R<sub>SS(ON)</sub> - V<sub>GS</sub>




Fig. 9.6 IGSS - VGS






Fig. 9.7 ISSS - VSS




Fig. 9.8 Dynamic Input Characteristics




Fig. 9.9 rth - tw




Fig. 9.10 Safe Operating Area





Fig. 10.1 Land Pattern Dimensions for Reference Only (Unit: mm)
